### **Notes To The Financial Statements**

#### **1. Basis of Preparation**

The interim financial statements are unaudited and have been prepared in accordance with the requirements of FRS 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad. The interim financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 December 2011.

These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 December 2011.

#### **2. Significant Accounting Policies**

The Group has adopted the Malaysian Financial Reporting Standards issued by the Malaysian Accounting Standards Board for accounting period beginning 1 January 2012.

#### **3. Auditors' Report on Preceding Annual Financial Statements**

The auditors' report of the Group's annual financial statements for the financial year ended 31 December 2011 was not qualified.

#### **4. Seasonal or Cyclical Factors**

The business operations of the Group are not significantly affected by any seasonal or cyclical factors.

#### **5. Unusual Items**

There were no unusual items affecting assets, liabilities, equity, net income or cash flows in the financial quarter under review.

#### **6. Changes in Estimates**

There was no change in estimates of amounts reported in prior interim periods that had a material effect in the current reporting quarter.

#### **7. Changes in Debt and Equity Securities**

There was no issuance or repayment of debt or equity securities, share cancellations and resale of treasury shares for the financial quarter under review, except for the following:

- a) Issuance of 717,300 new ordinary shares of RM1.00 each at par for cash through the exercise of 717,300 3-year warrants 2010/2013 that entitled the warrant holders to subscribe for one new ordinary share of RM1.00 each at an exercise price of RM1.00 for each warrant held; and
- b) The Company bought back 650,400 ordinary shares of RM1.00 each from the open market at an average price of RM1.72 per share. The shares purchased are being held as treasury shares in accordance with Section 67A of the Companies Act, 1965.

#### **8. Dividend Paid**

No dividend was paid in the financial quarter under review. However on 29 October 2012, the Company paid a single tier interim dividend of 4.0 sen per share in respect of the financial year ending 31 December 2012, amounting to RM3.58 million.

**12. Changes in Composition of the Group**

There were no major changes in the composition of the Group during the current financial period under review.

**13. Capital Commitments**

As at the end of the reporting quarter, the Group has approved and contracted for capital commitments of RM87.1 million in respect of property, plant and equipment.

**14. Changes in Contingent Liabilities**

There were no changes in contingent liabilities since the last annual balance sheet as at 31 December 2011.

**15. Review of Performance**

For the financial quarter ended 30 September 2012, the Group's revenue and pre-tax profit are RM61.101 million and RM6.733 million respectively, compared to revenue and pre-tax profit of RM79.439 million and RM11.146 million respectively for the corresponding period in the previous financial year. The decrease in revenue and pre-tax profit by 23.1% and 39.6% respectively were mainly due to the reduced oil and gas logistics activities as well as reduction in exports from the procurement logistics segment.

**16. Comparison with Immediate Preceding Quarter's Results**

For the financial quarter ended 30 September 2012, the Group reported revenue and pre-tax profit of RM61.101 million and RM6.733 million respectively, compared to revenue and pre-tax profit of RM66.322 million and RM5.104 million respectively for the preceding quarter. The decrease in revenue by 7.9% was due to the reason mentioned in Note 15 above. However, the increase in pre-tax profit by 31.9% was mainly due to the increased activities from existing contract logistics accounts.

**17. Prospects for the Current Financial Year**

The Group takes cognizance of the current uncertain global economic environment and will ensure that it takes the necessary measures to remain resilient, including focusing on providing value-added logistics solutions as well as maintaining cost efficiencies. Nevertheless, the Group remains confident of its business model and expects to perform satisfactorily in the current financial year.

There was no profit forecast announced in relation to the financial quarter under review.
